

## Subbasin Announcements

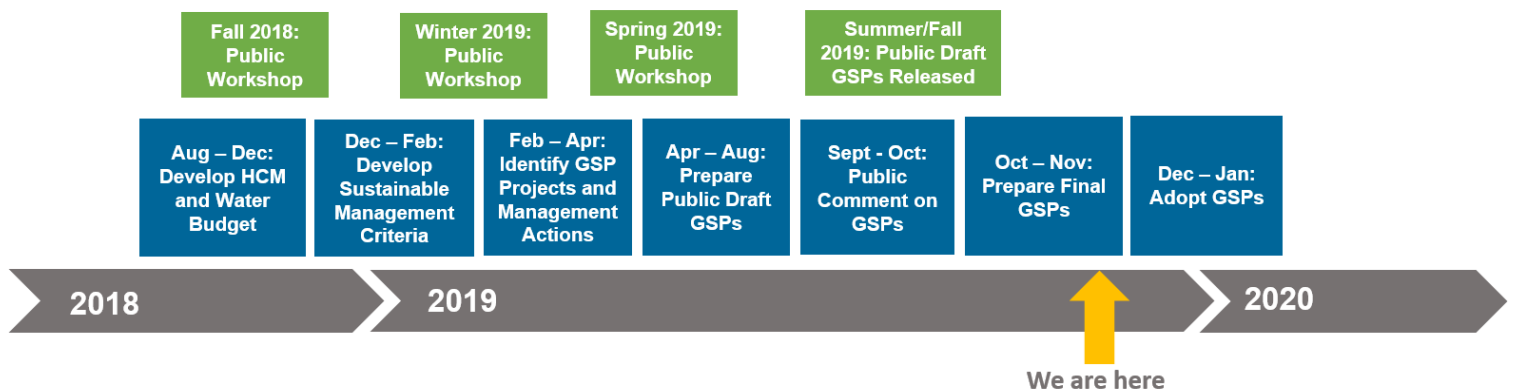
This month, representatives from the Delta-Mendota Subbasin continued to coordinate with groundwater sustainability plan (GSP) groups in adjacent subbasins. These meetings have allowed members from the Delta-Mendota Subbasin’s six GSPs and from bordering subbasins’ GSPs to further explain contents and development approaches within their respective Plans. Representatives from the Delta-Mendota Subbasin will continue to coordinate with adjacent subbasins and GSP groups prior to and through GSP implementation, which will begin for many neighboring subbasins in February 2020.

A coordinated application for the Round 3 Sustainable Groundwater Management Planning Grant was submitted earlier this month.

This application seeks to support a Subbasin-wide well census and inventory, development of a subsidence study at two identified locations along the Delta-Mendota Canal, and reimbursement for individual development costs for each of the six GSP groups.

Members of each of the six GSP groups continued to refine the Delta-Mendota Subbasin’s data management system and provide guidance as it is finalized. The data management system will support the development of the first Annual Report for each of the six GSP groups, which are due by April 1, 2020. These reports will provide context for each GSP group’s progress toward the groundwater sustainability objectives set forth in each GSP.
