Subbasin Announcements

The six groundwater sustainability plans (GSPs) within the Delta-Mendota Subbasin were submitted to the Department of Water Resource's SGMA Portal on January 23rd, prior to the Subbasin's January 31st deadline as a high-priority critically overdraft subbasin. Groundwater sustainability agencies (GSAs) within each GSP group adopted their respective GSP in public meetings prior to the GSP submission. Representatives from each GSP group coordinated the final GSP upload process and shared standard processes for each of the GSPs.

The Delta-Mendota Subbasin GSP groups are also continuing to prepare their respective data and updates for the first Annual Report submission due by April 1st. Monthly meetings of the Coordination Committee and Technical Working Group will continue through this next target date.

In further news...

DWR released draft recommended funding awards for the Proposition 68 Sustainable Groundwater Management Round 3 grant funding on January 24th. In this draft funding list, DWR's recommended award for the Delta-Mendota Subbasin matches the requested amount of \$500,000. There is a 15-day public review and comment period until February 10th, after which the final funding awards will be announced.
