The Well depths and the PH/TDS readings were presented to the Board along with the flow meter readings.

**COUNSEL REPORT:** In regards to legal matters affecting the District –<u>Leg Committee</u>: AB2201 – they are working on exceptions for this bill <u>SGMA:</u> the amended GSP has been adopted and should be uploaded today.

## **ENGINEERING CONSULTANT REPORT:**

SGMA: in 2025 they will be drafting a new GSP. We are currently in the water quality and subsidence evaluations process right now.

Projects: Meter project- out to bid in September. Pigging the city water line will happen in November. CW 8,9,A11- A11 is getting hooked up to electricity. CW8 &9- we are looking for good sites. Lift 3 - still working on the SAM.gov program – trying to get it renewed so we can receive the USBR grant funding. P&P will be looking into a screen to help get the weeds out of the canal.

#### MANAGER REPORT:

1. 2022 Critical Water Year Tracking: an updated plan was presented to the Board. We are going to have to put in meters at Lift 1 & 2.

- 2. Salary Evaluation/Resolution 2022-02: Approve full time employee raises after review Director Pucheu motioned for approval and President Salvador seconded the motion.
- 3. Hyacinth/ Boat Spraying: our crew has been spraying the hyacinth using the boat. We will also have the helicopter spraying done.

- 6. USDA/NRCS Water Smart Grant: there is \$3 million available for the grant that would go to the farmers within the Districts that apply. This funding is for improving conservation efforts for their farms. TID will be joining the group applying for this grant.
