MINUTES: The minutes of the meeting of July 19, 2023 was approved on voice count. Director Ayerza motioned for approval and Director Pucheu seconded the motion.

TREASURER REPORT: The <u>Cash Flow</u> statement was presented for the month of July 2023 including the cash disbursements and receivables. Director Pucheu motioned for approval of the Treasurer report. Director Ayerza seconded the motion.

WATERMASTER'S REPORTS: Water use – irrigation and drinking water: Watermaster Wade reported on the usage totals for the month of July 2023, along with the well pumping totals and the Mendota pool reporting. The well depths and the PH/TDS readings were presented to the Board as well as the flow meter readings.

DIRECTOR REPORT: none

COUNSEL REPORT: In regards to legal matters affecting the District —<u>Kings River</u>: power revenue checks will be coming soon. They have experienced some flooding damage on the lower river. <u>State Leg:</u> no new updates <u>SGMA</u>: they are still working on the 1 GSP for the subbassin. The draft MOA is almost ready. They are currently working on how many seats there will be on the Coordination Committee. They expect a resolution by the end of the month and then they will be able to send out the MOA.

ENGINEERING CONSULTANT REPORT:

SGMA: they are collecting water quality samples today

<u>Projects</u>: <u>Meter Project</u>: issues have been resolved and the project is moving forward. There is a list forming of connection issues in the system, multiple houses fed by one connection or water line running thru the middle of a property to another property behind it. We will need to have a meter for each individual property. <u>Wells</u>: Well 8 – they will start drilling 30 days after all parties have signed the contract. The equipment portion is going out to bid. The goal is to have the equipment portion ready to go as soon as the well is drilled. Well 4- Cal West Rain is waiting on the column pipe to come in. An Executive Order from the Governor is in place for flood maintenance. Basically, we can get to work on the levees and clean up the sand barge without the "red tape". We will have until November to get this work done.

MANAGER REPORT:

- 1. 2023 Critical Water Year Tracking: Updated report was presented.
- 2. Commercial Water/Meters License: with regards to the list of issues P&P is finding for the meter project we will need to wait until the end of the project to resolve these. The list of places will have to be split up and have one meter going to each parcel/property. We will need to know the cost to make these corrections and determine who pays for these. Joe will work on this.
- 3. United States Bureau of Reclamation/Letter: we still haven't received a response.
- 4. Hyacinth Coordination/Spraying: there will be a meeting for the helicopter spraying next week. We don't need this in our area as the boat is working out very well right now.
- 5. Pool Pumpers/ Gauge: Wildlife Refuge has removed the gauge that was in their territory. Chase Hurley (rep for the pool pumpers) has asked if we could put a gauge in our area. They will share the water quality data with us. The Board is ok with this. We will need to setup some kind of agreement as well as an easement.
- 6. 2023 TID/BBQ: the Lions Club will be doing the BBQ. It will be on November 17th.
