President Salvador called the meeting to order at 8:30 am.

MINUTES: The minutes of the meeting of March 20, 2024 was approved on voice count. Director Ayerza motioned for approval and President Salvador seconded the motion.

TREASURER REPORT: The Cash Flow statement was presented for the month of March 2024 including the cash disbursements and receivables. Director Ayerza motioned for approval of the Treasurer report. President Salvador seconded the motion.

WATERMASTER'S REPORTS: Water use – irrigation and drinking water: WaterMaster Wade reported on the usage totals for the month of March 2024, along with the well pumping totals and the Mendota pool reporting. The well depths along with PH/TDS readings were presented to the Board.

Maintenance projects: Started the new reservoir project today

DIRECTOR REPORT: none

NEW BUSINESS/ACTION ITEMS:

A. Easement Agreement with Tranquillity Public Utilities District (sewer lift station) - tabled until next month

COUNSEL REPORT: In regards to legal matters affecting the District: Legislation: AB2079 – prohibits drilling ag wells moving forward in an effort to stop subsidence – ACWA is opposed unless amend.

SGMA: There was a hearing for TLSB – the Basin went into probation. They will have to resubmit their plan and wait 3 months for review.

ENGINEERING CONSULTANT REPORT:

<u>SGMA</u>: they are currently working with SWB for the single GSP so we can be compliant with what they want to see. Currently working on policies to help keep everyone on the same page. All wells in the basin are required to have meters. The new Demand Management Policy is an issue as they want no pumping at all – still working on this..

<u>Projects</u>: <u>Meter Project</u>: still moving forward. Working on new city water rates for the Prop 218 <u>Well 8</u>: this has not been developed yet because of the weather.

MANAGER REPORT:

- 1. 2024 Water Schedule Tracking: updated report was presented
- 2. 2nd Revised Water Schedule: the new schedule was presented that has been sent to USBR
- 3. KRWA Water Update: no flood flows yet. We are still waiting to see if we will be able to do some sort of exchange program for the Kings River Water
- 4. SLWD Update 2024 CVP Water: we are moving forward with the transfer which should begin April or May

- 5. Boat Spraying/JID: a question was asked if we would rent out our spray rig since we aren't permitted to spray outside our own district. The Board decided to not allow this due to liability concerns
- 6. Cal/Trust: information was provided about the company. They have different funds the Board chose the Liquidity fund which is a stable dollar in dollar out. There are no minimums or maximums with regards to investments or withdrawls. There are no fees for the public agency. After discussion the Board agreed to move forward with this company. They chose the Liquidity fund and to move the funds from the New Well CVCB account to start with. Direction was given to move forward with the application process. Director Ayerza motioned for approval to move forward with Cal Trust and President Salvador seconded the motion.
