Our water system recently violated a drinking water standard. Although this is not an emergency, as our customers, you have a right to know what happened, what you should do, and what we did to correct the situation.

We are required to monitor your drinking water for specific contaminants on a regular basis. Results of regular monitoring are an indicator of whether or not our drinking water meets health standards. Between June- September 2024, we did not meet all monitoring requirements for Lead and Copper, and therefore cannot be sure of the quality of our drinking water during that time.

What should I do?

- You do not need to boil your water or take other corrective actions.
- The table below lists the contaminant we did not properly test for between June-September 2024 and how many samples we are required to take and how often, how many samples we took, when samples should have been taken, and the date on which follow-up samples will be taken.
